Widespread adoption signals a new standard in operating room efficiency, compliance and vendor scheduling across the ambulatory surgery center market.

TAMPA, FL – April 1, 2025 — OR TRAX, the healthcare tech company behind the iBadge™ platform, announced today that **30 ambulatory surgery centers (ASCs)** across the U.S. have adopted its automated vendor credentialing and notification system **in recent months**. The rapid expansion reflects a growing industry shift: surgical facilities are looking for ways to eliminate the administrative grind of managing vendor reps while increasing compliance, uptime, and OR readiness.

Instead of juggling spreadsheets, emails, phone calls, and binders, OR TRAX gives ASCs a centralized, cloud-based hub that handles the entire vendor management workflow—from credentialing to check-in, to real-time OR notifications. Why More ASCs Are Making the Switch

ASC administrators are under pressure to do more with less. Surgical volume is rising. Staffing is tight. And compliance expectations from **CDC, HIPAA, AAAHC** and **The Joint Commission** are only getting stricter. For procedures that rely on vendor-supplied instrumentation or implants, the margin for error is thin—and the cost of mistakes is high.
